Meet Your Auxiliary Officers

President, Catherine Massey: Catherine was born in Huntsville, Texas, a fifth generation Texan. She notes husband Sam Massey is from Gallatin, Tennessee, but he got her a soon as he could. She and Sam have been married 17 years. They met in a Bible study for singles. Other family includes her mother and three sisters.



Catherine studied at UT Austin where she received her BFA in Studio Art. Before she married she worked in residential real estate.

DAR has been a very important part of her family. Her mother, two sisters and three nieces are in her DAR chapter, the John McKnight Alexander Chapter of Houston. Sue married a man in the military and traveled the United States and Japan. They wanted their children to grow up in Texas so they returned. It was here Sue continued her education. When the children were 7, 10 and 12, her husband died of cancer. Sue was just 33. Mutual friends introduced her to Pete Lenes who was also military and a mortgage banker. Pete was divorced with two children ages 10 and 13. They married and blended their two families, her son and two daughters and his son and daughter. She recounts, "We had some very interesting family outings as well as family vacations. You have not lived until you have five teen agers at one time. Between the five of our children we have three grand sons, two grand daughters, three great grand daughters and one great grand son." Pete and Sue will celebrate their 40th wedding anniversary in October at our TXSSAR BOM meeting in Galveston.






A Time for Celebration:

Jack and Katherine Morton, of the Freedom Chapter, chose to celebrate two milestones with their SAR friends. First, they celebrated their 60th Wedding Anniversary on Saturday. This is awesome. They are such a wonderful couple. Second, after many years of volunteer work at the Montgomery County Library's Genealogy Room, they are retiring from there. As a patron of the library I can attest, their knowledge and help will be sorely missed by patrons.



Housekeeping in Colonial days was challenging to say the least. At times we all wax nostalgic about those days of our patriots. There they were enjoying the bucolic life of a planter, a city lawyer or a craftsman. They controlled their destiny right, they enjoyed life. Well, it is probably hard to sell that story to anyone in DAR or SAR. We recognize the hardships under which our ancestors lived. This page is just an attempt to share some of those times. We will try to include some tidbits about the Colonial days and a recipe from the era. The recipe will be updated so that the reader doesn't have to translate gills and such.

Below are some quotes from "The Compleat American Housewife, 1776"

- "Women are creatures without which there is no comfortable living ... it is true of them what is wont to be said of governments, that bad ones are better than none." John Cotton
- "The grand Arcanum of management can be stated in three simple rules: Let every thing be done at a proper time, keep every thing in its proper place, and put every thing to its proper use." Mary Randolph, Virginia
- "Always when you sweep a room, throw a little wet sand all over it, and that will gather up all the slew and dust, prevent it from rising, clean the boards, and save the bedding, pictures, and all other furniture from dust and dirt."
- "The stories one hears of Southern hospitality are true I do believe. I have heard of a gentleman and his wife, who, being asked to dine at a residence on St. Simon, found that during the meal a boat had been sent to Darien, fifteen miles distant, for their luggage, and that so much pleased were host, hostess, and guests with one another, that their stay was prolonged until two children had been born to the visiting couple."

Sally Lunn Bread

Sally Lunn bread was a "receipt" brought to the colonies from their English hearths. It was originally baked in Sally's ovens in Bath, England. It was a favorite in Gatsby's Tavern in Alexandria, Virginia. Gatsby's hosted the likes of Washington, Jefferson, Randolph and most of the other Founding Fathers.

"Bread is that article of food of the first necessity, combining the sustaining powers of the animal and vegetable kingdoms in one product. In these Colonies we have as many breads as there are fish in the sea. The good cook should know a variety and be skillful in the use of her brick oven." Compleat American Housewife, 1776

Sally Lunn Bread

1 pkg	active dry yeast
1/4 cup	warm water
1/2 cup	hot milk
2/3 cup	butter or margarine, softened
2 tbs	sugar
3/4 tsp	salt
2 cups	all purpose flour
2 eggs	well beaten

Dissolve the yeast in warm water. In a separate bowl, pour hot milk over butter, sugar and salt.

When the butter has melted, stir in 1/2 cup flour.

Beat until smooth.

Add the yeast mixture; mix well.

Add half of the remaining flour and beat until no lumps remain.

Add eggs; beat hard.

Add remaining flour and beat vigorously at least 5 minutes.

Scrape down batter from the sides of the bowl. Cover the bowl, and allow rising in a warm place until doubled in size – about 45 minutes.

When doubled, beat again at least 5 minutes, and then spoon into a greased 1 1/2 quart ring mold or Turk's head mold. Cover and let rise again until doubled.

Bake at 350 degrees for 30-35 minutes, or until golden brown. Yield: One ring loaf.
