### 1777 - Saratoga

As General Burgoyne digs in North of Saratoga NY, on Oct 3rd General Clinton sends troops up the Hudson River towards Albany. On October 6th his forces take Fort Clinton and Fort Montgomery. But these actions were too little and too late to help Burgoyne who was rapidly running out of supplies.



On October 7th he moved against the American left flank on the Bemis heights only to be repulsed. Then the unauthorized appearance of General Arnold drove forward the American counter attack, taking two redoubts before nightfall. Burgoyne was forced to retreat North and by Oct 8th was in the same fortifications he was in back on September 16th.

By Sept 13th Burgoyne was surrounded. Unable to break out, and informed Clinton wouldnot reach him, Burgoyne asks Gates for a cease-fire. Three days later, in an attempt to pullPatriot troops off Burgoyne, General Clinton's troops burn the town of Esopus, New York.

Again its too-late and on Sept 17th Burgoyne surrenders to Gates.

## OUR FOUNDING FATHERS

### **Richard Bassett**



Richard Bassett (April 2, 1745 – September 15, 1815) was an American politician, attorney, slave owner and later abolitionist, veteran of the American Revolution, signer of the United States Constitution, and one of the Founding Fathers of America. He also served as United States Senator from Delaware, chief justice of the Delaware Court of Common Pleas, governor of Delaware and a United States circuit judge of the United States Circuit Court for the Third Circuit.

#### **Education and career**

Born on April 2, 1745, in Cecil County, Province of Maryland, British America, Bassett pursued preparatory studies, then read law. He was admitted to the bar and practiced law in Delaware. By concentrating on agricultural pursuits as well as religious and charitable concerns, he quickly established himself amongst the local gentry and "developed a reputation for hospitality and philanthropy." He was a member of the Delaware constitutional conventions of 1776 and 1792. He was a member of the Council of Safety in Dover. Delaware from 1776 to 1786. He served in the Delaware State Militia as a company captain of the Dover Light Horse Regiment from 1777 to 1781. He was a member of the Delaware Legislative Council (now the Delaware Senate) in 1782. He was a member of the Delaware House of Representatives in 1786. He was a delegate to the Constitutional Convention in 1787, and was a signer of the United States Constitution. He was a member of the Delaware convention which ratified the United States Constitution in 1787. He was in private practice in Wilmington, Delaware from 1787 to 1789.

Bassett was elected to the United States Senate from Delaware and served from March 4, 1789, to March 3, 1793, first as a member of the Anti-Administration Party and later as a member of the Pro-Administration Party. Due to his name coming first alphabetically out of all 20 senators who commenced their first term on 4 March, 1789, Bassett is the most

senior senator to have served in the United States Senate. Bassett was chief justice of the Delaware Court of Common Pleas from 1793 to 1799. He was governor of Delaware from 1799 to 1801.

Bassett was nominated by President John Adams on February 18, 1801, to the United States Circuit Court for the Third Circuit, to a new seat authorized by 2 Stat. 89. He was confirmed by the United States Senate on February 20, 1801, and received his commission the same day. His service terminated on July 1, 1802, due to abolition of the court.

#### Later life and death

After leaving the federal bench, Bassett became a planter in Cecil County.

While he was a slave owner, after converting to Methodism in the 1780s, he freed his slaves and campaigned for the state of Delaware to abolish slavery.

He died on September 15, 1815, on his estate Bohemia Manor in Cecil County. He was initially interred in Cecil County, and in 1865 his remains were re-interred in Wilmington and Brandywine Cemetery in Wilmington, Delaware.

### Legacy

Bassett was the grandfather of Richard H. Bayard and James A. Bayard Jr., both United States senators from Delaware.

Bassett Street in Madison, Wisconsin, is named in Bassett's honor.

Bassettown, now Washington, Pennsylvania, was named in Bassett's honor by his cousin David Hoge.



## FUTURE FIRST LADY ELIZABETH MONROE RESCUED LAFAYETTE'S WIFE DURING THE FRENCH REVOLUTION'S REIGN OF TERROR.

As head of the Paris National Guard, one of Lafayette's charges was to safeguard the Royal family (from 1791 to 1792, France was officially a constitutional monarchy). But in 1792, the radical wing of the revolution took over, the king was dethroned, and even the brilliant Marquis de Lafayette could no longer pull off being both a revolutionary and a nobleman. Facing imprisonment and likely execution as an enemy of the state, Lafayette fled France in 1792. He had hoped to catch a boat to America from a Dutch port city, but he was caught by Austrian troops who controlled the Netherlands first.

While he was lying in an Austrian prison, Lafayette's wife, Adrienne, was placed under house arrest along with his daughter. They were then moved to a prison. They were the lucky ones in the family: Adrienne's mother, grandmother, and sister were all executed during the Committee of Public Safety's Reign of Terror. But in 1794, at the height of the Terror, James Monroe became the new nation's Minister to France. Monroe and his wife, Elizabeth, were intent on insuring Adrienne's safety. The couple knew they had to tread carefully.

To draw attention to Adrienne's plight, they bought a carriage, and Elizabeth rode it to the prison Adrienne was held in. She attracted a crowd along the way, curious to see who she was visiting. When Elizabeth arrived at the prison, she embraced Adrienne in public, who was obviously relieved the carriage was not there to take her to her execution.

The crowd's emotional response helped convince the Committee of Public Safety to grant Adrienne's freedom, and she and her daughter traveled to Austria to be with Lafayette.

## OUR AMERICAN PATRIOTS

Captain Zachariah Isbell, Sr. 6<sup>th</sup> Great Uncle of Compatriot Larry Joe Reynolds



Zachariah Isbell, Sr. was born about 1722 in Virginia.

His wife's name is not known for sure. He was a sheriff, magistrate, and justice in Virginia.

Their children may have included:

Louvisa Isbell (1743, married John Carr), Zachariah Isbell, Jr. (1745), William Isbell (1747), Jason Isbell (1756), Hannah Isbell (1760, married Taylor).

He was a captain in the French and Indian War.

On March 7, 1759, he received a land grant for 250 acres in the Craven District (later Camden District) of South Carolina. He was a tax collector, Justice of the Peace, and a magistrate there.

In 1762 he was on the tax list of Rowan County, North Carolina.

On July 16, 1766, in Camden District, South Carolina, Zachariah Isbell, Sr. sold land to Jeremiah Potts and Zachariah's wife, Elizabeth Isbell, signed to release her dower rights.

In 1771 and 1772 he was on the tax list of Surry County, North Carolina.

They moved to Washington County, North Carolina (later Tennessee) where he was a magistrate judge. He was one of 13 commissioners appointed to form the Watauga Settlement. In 1772 he served on the first court in Tennessee.

On March 25, 1775 he witnessed the deed for the Watauga Purchase of the East Tennessee lands from the Cherokee and soon after bought land from Jacob Brown.

In 1776 he signed the petition of Watauga settlers asking to become part of North Carolina.

In 1778 he served on the first court in Washington County. In November, 1778

Ord[ered]. Jacob Womack, Jesse Walton, Geo. Russell, Joseph Willson, Zach. Isbell, and Benjamin Gist appointed to lay off the place for erecting the Court house, prison stocks, and the said return is ord. filed in the court office.

Ord. that Patrick Murphy be fined for 20 lbs. for insulting Zachariah Isbell a member sitting on the bench.

State vs. Patrick Murphy for stealing two hogs the property of Zach Isbell and Thomas Evans. Jas. Crawford and Wm. Murphy witness for the State, John Smith, Richard Travillian and John Redding witness for Murphy. Sworn. The Court ord. that Murphy pay to Zach Isbell for his hog 26 lbs., and for Evans hog 10 lbs. and receive on his bare back well laid on by the Sheriff, 20 lashes.

1778 Washington County tax list included Zach Isbell and Zach Isbell, Esq.

Zachariah Isbell and his son Zachariah, Jr. both served in the government of the Watauga Association, and they both fought the British with Colonel John Sevier in the Battle of Kings Mountain, October 7, 1780.

Zachariah and Elizabeth Isbell signed as witnesses to a deed for Jacob Brown on October 9, 1781.

In 1784, Zachariah Isbell, John Sevier and Jesse Walton were appointed to confiscate the properties of Tories in Washington County.

He died about 1788 and is believed to be buried at Cherokee Creek Baptist Church Cemetery.

## THE FENCE-SITTERS



In the pledge of allegiance to our flag we declare our commitment to "one Nation under God, indivisible, with liberty and justice for all." The statement confirms our fidelity to the Declaration of Independence and the Constitution. It remains a goal, an ideal for all Americans of good will.

Certainly, we were not "one nation" when it all began in the 1700s leading up to the War for Independence.

Historians have concluded that by 1776 about 20% of the population of the British colonies in America supported separation and independence. About 20% were loyalists who remained loyal to England and the king. By far the largest group, making up about 60% of the population, was undecided. They were fence-sitters. In the 1800s a group supporting both sides were known as "mugwumps", said to be sitting on a fence with their mugs facing one side and their wumps the other...Today they may be called "independents".

With so many fence-sitters in 1776, the cause became as much an effort to win popular support as it was to win victories on the battlefield. The publication of Thomas Paine's Common Sense in January of 1776 added

energy and passion to the patriot cause as did the December 26, 1776 American victory at Trenton. The Revolution fractured relationships among neighbors and friends. It also separated families, the most notable being the split between Benjamin Franklin and his son, William, a Loyalist governor of New Jersey who supported the British effort during the war. They never reconciled their differences.

By 1787, when our patriot fore bearers produced a constitution it was designed for all people – patriots, loyalists, and fence-sitters – and to heal a divided America. It embraced the principles set forth in the Deceleration of Independence. Every citizen has certain fundamental rights that no government may ever take away. It created a means to expand the franchise and a path to end slavery.

The Heritage Foundation captured it well when in an essay titled The Genius of the Constitution, it stated, "The great genius of the Constitution is this: it permits the people to govern themselves by putting the power of government in their hands, by protecting them from those who would take power or liberty from them, and by giving each successive generation the ability to improve upon the

government bequeathed to them by those who came before."


