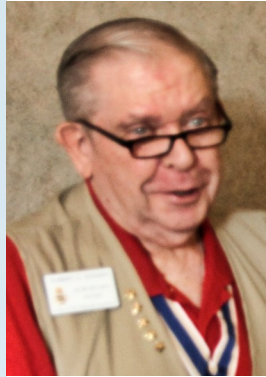

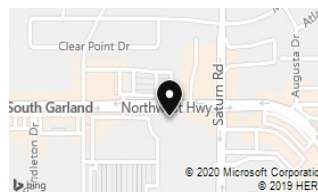
Editor's Note:
