President's Message:

Good afternoon fellow Compatriots,

I hope that this newsletter finds you well. We have officially survived the winter and are well on our way to the warmer months.

We also have completed our 130th State Conference in Richardson where we installed our new State Officers and received awards from 2024. Among those awards our chapter was awarded 2 different CAR (Children of the American Revolution) related awards. We were well represented in all the Youth Contests with 1 st place in the Essay Contest, 3rd Place in the Video Contest, 3rd place in the Brochure Contest and 5th place in the Oration Contest.

Our new state President Mel Oller revealed that his focus for the upcoming year would be on member reinstatement. During the last year the Texas SAR has lost 500 dues paying Members. The President told us that in a typical year we will reinstate approximately 300 of those members. In the last year our chapter specifically had 12 members not pay their dues for this year. We as an organization are going to be actively pursuing these lost members and attempting to get as many as possible reinstated.

Big news was also officially revealed. In July of 2029 the SAR National Congress will be held in San Antonio. This will be a fabulous opportunity for our State and for our members. Usually these National Meetings are held in other states and getting to them takes a lot of effort. But that will not be a problem in 2029.

First of all we have the 250th Anniversary of the Battles of Lexington and Concord and "the Shot Heard round the world" on April 19, 2025. I would like to encourage all of our members to participate in this initiative on the night of Friday April 18, 2025. 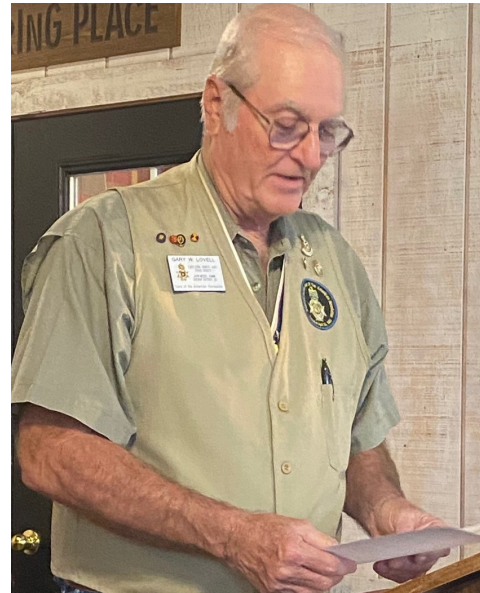


