**President** Mike Connelley called the meeting to order.

James Alderman reported the nominating committee is working diligently on the slate of officers for the next two year term, beginning in January 2018.

The newsletter has been suggested to out in PDF format rather than Word format; only one chapter member present expressed concern over being able to view the PDF format; other comments were positive toward using PDF. No firm decision was made during the meeting.

The National SAR organization has come up with a new "lifesaving medal" to be part of the Public Service and Heroism Report. **Chapter member Mike Howe** will monitor/coordinate the chapter's presentation of this medal. The Lifesaving medal is to be presented when "acts that save a human life without necessarily placing the life of the rescuer in imminent danger. It is intended primarily for citizens' not in uniform but does not exclude police, fire."

The Texas SAR will host the Board of Managers meeting in Galveston during the month of October. A report will be brought back to the chapter at the October meeting.

- President Connelley called for a motion to adjourn and led the chapter in the SAR recessional.
- Chaplain Roger Tate gave the benediction and the meeting was concluded at 10:30 a.m. In attendance, per the sign-in sheet and observation, were 17 members and one guest for a total of 18 attendees.
