Dear SAR Members,





#### TWO HUNDRED FIFTY YEARS AGO



The Republic of Vermont January 15, 1777, to March 4, 1791

July 4, 1776, 13 of Britain's North American colonies declared their independence. And while New York, Massachusetts, Virginia and a host of others joined in that rebellion, one future U.S. state was notably absent from the patriot roll call – Vermont.

Situated east of New York and west of New Hampshire, Vermont was no friend of its neighboring colonies. In fact, the territory had spent the years leading up to the revolution locked in a dispute with the colonies on its border over land. Both New York and New Hampshire had laid claim to Vermont — many Americans at the time considered the inhabitants of the territory as little more than troublemakers.

Hostilities between Vermont residents and encroaching New Yorkers even led to bloodshed in March of 1775 when colonial administrators and militia clashed with settlers leading to the deaths of two locals. The incident became known as the Westminster Massacre. After the violence, Vermont raised its own army to safeguard its borders. They became known as the Green Mountain Boys.



The name was a play on the French words *vert* meaning "green" and *mont* meaning "mountain." Despite stormy relations with its neighbors, Vermont still leant its support to the 13 colonies as tensions between the Continentals and Great Britain heated up in 1775. In fact, less than a month after the battle of Lexington and

Concord (the first clash of the War of Independence), a regiment of Green Mountain Boys, under the command of Ethan Allen, swooped in and captured the British fort at Ticonderoga, New York. The stone fortress sat on the western shore of Lake Champlain, just opposite from Vermont territory. Allen's men, along with a detachment of Connecticut militia under the command of Benedict Arnold, also



grabbed other British held forts in the area, like Crown Point and Fort George, and even captured a Tory settlement in Quebec. Two years later, the Green Mountain Boys would take part in the Saratoga cam-

paign – a decisive victory for the American cause that saw a British army from Quebec under John Burgoyne shattered as



it marched down the Hudson River valley.

Yet despite its formal participation in the revolution, the Continental Congress refused to recognize Vermont's legitimacy, largely at the insistence of New York, which still considered it something of a rogue state.

So in January of 1777, the territory declared a separate independence establishing itself as a sovereign nation—the Republic of Vermont. It issued its own currency, set up a national postal service and even named its own president: Governor Thomas Chittenden. Delegates from the tiny republic's various towns and counties gathered at a tavern in the village of Windsor to draft Vermont's own constitution—one that extended the vote to non-property owners and even outlawed slavery. It was the first document of its kind in the New World and was implemented a full decade before the U.S. Constitution was written.

Interestingly, Vermont's go-it-alone approach to nation building was short lived. When redcoats and their Mohawk allies invaded the region in 1780 to burn settlements and take prisoners, the Green Mountain Boys' own Ethan Allen, his brother Ira and Gov. Chittenden sent out feelers to British authorities in Quebec for secret negotiations. While the talks were ostensi-

bly an attempt to secure the release of captured militiamen, the ultimate objective was hammering out a separate peace — one that might even lead to a resumption of crown control over the former colony if necessary. Although few details of the discussions were formally made public, when news of them leaked to Vermont's assembly (and later in other states' legislatures) it created an epic scandal. The debacle became known as the Haldimand Affair — named for the British governor at Quebec, Frederick Haldimand.

Despite claims by Allen and Chittenden that the prospect of a reunion with the crown was little more than a ruse intended to secure the release of prisoners, it was nonetheless politically damaging for the Vermont's government. The Continental Congress even pondered an all out invasion of the territory to bring the rogue republic to heel.


The negotiations stalled and soon British troops were clashing with Vermont militia on the state's western border.

Following the English defeat at Yorktown in 1781, Vermonters who still believed security lay in peace with the crown suddenly changed their tune. With the Revolutionary War drawing to a close, Vermont sought to resolve its land claims with its neighbors. Eventually, the republic agreed to pay New York \$30,000 in silver for land and by 1790, Vermont ceased to be an independent republic and formally joined the United States.

The Green Mountain Boys would be disbanded following the revolution, but its regiments would be reconstituted during the War of 1812, the Civil War and the Spanish American War. Today, the state's national guard still bears the name.

There is not list of signatories for the 1777 Vermont Constitution, however, the delegates elected Thomas Chittenden, Nathan Clark, Jonas and Joseph Fay, Moses Robinson, Ira and Heman Allen, and Matthew Lyon to the Council of Safety, the interim government. These men faced the daunting task of putting together a government in the middle of a war. The Republic would last fourteen years. Most civil records were kept by the towns. This included births, marriages, and deaths. These are not complete if they survived at all.

There are *Vermont Militia Rolls found in a book by John E. Goodrich published in Rutland, VT, by The Tuttle Company 1904.* I found the book while researching for Stephen Delano of Woodstock Vermont who moved there from Dartmouth, Bristal, Massachu-





setts before 1773 with his brothers Amasa and Jonathon Delano. Amasa and Jonathon are listed in the rolls but not Stephen. Due the lack of Township and State records, the only documents found for Stephen were the birth rerecords of his children.

The Cherry Valley Massacre, November 11, 1778, was one of three major attacks in 1778 on American 'rebel' wilderness settlements and military outposts. British Loyalists and Native American forces, particularly four tribes of the Iroquois Nation Confederation; Mohawk, Seneca, Onondaga, and Cayuga ascended on the New York settlement, destroying it while killing and capturing many of its residents. The other two tribes of the Six Nations, Oneida and Tuscarora, did not participate, having allied with the rebellious Americans. The other two significant assaults occurred prior to Cherry Valley; the Wyoming Massacre in northeast Pennsylvania – July 3, 1778, and German Flatts, New York – September 17, 1778.



The Cherry Valley massacre was an attack by British and Iroquois forces on a fort and the town of Cherry Valley in central New York on November 11, 1778, during the American Revolutionary War. It has been described as one of the most horrific frontier massacres of the war.<sup>[1]</sup> A mixed force of Loyalists, British soldiers, Senecas, and Mohawks descended on Cherry Valley, whose defenders, despite warnings, were unprepared for the attack. During the raid, the Seneca in particular targeted non-combatants, and reports state that thirty such individuals were killed, in addition to a number of armed defenders.

. An infuriated George Washington in response to Iroquois and Loyalist massacres of American settlements in the Wyoming Valley, and Cherry Valley, ordered a campaign for the total destruction and devastation of

George Washington's order.

"George Washington to Major General John Sullivan, 31 May 1779

To Major General John Sullivan

[Middlebrook, 31 May 1779]

Sir,

The expedition you are appointed to command is to be directed against the hostile tribes of the six nations of Indians, with their associates and adherents. The immediate objects are the total destruction and devastation of their settlements and the capture of as many prisoners of every age and sex as possible. It will be essential to ruin their crops now in the ground and prevent their planting more.

The troops to be employed under your command are—Clintons, Maxwells, Poors and Hands Brigades and ten independent companies raised in the State of Pennsylvania—In Hands Brigade, I comprehend all the detached corps of Continental troops now on the Susquehanna and Spencers regiment—Cortlandts I consider as belonging to Clintons Brigade—Aldens may go to Poors & Butlers & the rifle corps to Maxwells or Hands according to their comparative strength and circumstances.....

Relying perfectly upon your judgment prudence and activity—I have the highest expectation of success equal to our wishes; and I beg leave to assure you, that I anticipate with great pleasure, the honor which will redound to yourself and the advantage to the common cause, from a happy termination of this important enterprise. Given at Head Quarters Middle Brook 31st May 1779."

Battle of Newport NY

He ordered Major General John Sullivan to head up what is known as the 1779 Sullivan Expedition. Major General John Sullivan, to command what is known as the 1779 Sullivan Expedition, to eliminate the armies of the Iroquois involved the attacks and lay waste to their newly planted fields of crops so they would have nothing is store for the winter to come.

Three Continental Army brigades of 3200 seasoned

soldiers carried out a scorched-earth campaign in the territory of the Iroquois Confederacy in what is now central New York totally defeating the Iroquois in upstate New York. When the military threat from Chief Brant and the Loyalist was no more, Sullivan conducted his order the lay waste to the villages and fields until they finally finishing the Sullivan Expedition at Fort Sullivan at the end of September 1779.



FOTNOTE! Britannica

The Iroquois (Haudenosaunee; "People of the Longhouse") Confederacy of upper New York state and southeastern Canada is often characterized as one of the world's oldest participatory democracies. The confederacy's constitution, the Great Law of Peace (Gayanesshagowa), is believed to have been a model for the U.S. Constitution, partly because Benjamin Franklin was known to have been much interested in the structure of the confederacy and partly because of the balance of power embodied in the Great Law.



December 1, 1779 to June 22, 1780 - Hard Winter at Morristown New Jersey

On December 1, 1779, the Continental Army, under the command of General George Washington, established winter headquarters at Morristown, New Jersey. The army stayed there until June 1780. It was one of



the worst winters ever endured and is known as the Hard Winter. Washington's Army was roughly 10,000 men, with troops from Canada, Connecticut, Delaware, Maryland, Massachusetts, New York, and Pennsylvania. They built their winter cam at Jockey

Hollow, close to the Ford Mansion where George and Martha were lodging, clearing 2,000 acres of tress and building 1,200 small houses.

The difficult winter had many of the soldiers questioning why they were putting themselves through such extreme hardship. In December 1779, Washington sent a circular letter to the states and informed them the situation was dire and he was concerned the army would simply disband because they had "never experienced a like extremity at any period of the War."

Joseph Plumb Martin was a soldier from western Massachusetts. He published his memoirs of his time in the Continental Army after the war. He said the soldiers were "venting our spleen at our country and government, then at our officers, and then at ourselves for our imbecility in staying there and starving in detail for an ungrateful people who did not care what became of us, so they could enjoy themselves while we were keeping a cruel enemy from them."

The winter was so harsh that not much came of the threats, but as the spring of 1780 approached, the situation was still dire in the Continental Army camp, and the men badly needed food. Green wrote, "A Country, once overflowing with plenty, are now suffering an Army employed for the defense of every thing that is dear and valuable, to perish for want of food."

On April 29, a shipment of supplies, which included food and meat in the form of pork and thirty head of cattle arrived at Joscky Hollow.

Los Cuco's Restaurant, Kingwood, Texas


Meeting began at 11:35 AM with the opening prayer, Pledge Allegiance, Texas Pledge, and SAR pledge by chapter president Abe Adbmoulaie.

Members present included: Bill King, Merv Hartwick, Lewis (Skip) Hawley, Joe Potter, Abe Abdmoulaie, Larry Stevens, Michael Anderson, Ben Baskin, Ski Grumboski, Richard Payne, Ray Cox, Kermit Breed, B. Ray Miske, Harry Salisbury. Freedom Chapter President David Hamaker. Guests include Jeanne Hartwick and Samantha Ballard.

Abe reminded everyone that the U S Navy and US Marine Corp was established on October 13, 1775 by an act of the Continental Congress.

Abe then introduced the speaker, David Hamaker who is the President of the SAR Freedom Chapter and also the Texas Color Guard Commander. David loves fishing and hunting and other outdoor activities. He is retired after a career rail road employee.

David's position in the Freedom chapter is president and is an active recruiter of new members to SAR. This year the Freedom Chapter has inducted into membership 24 new members. Their oldest member is 87.

Officer reports are as follows:

2nd VP Jim Pinkerton stated that 3 events are forthcoming, 2 in November and 1 in De-



cember. Next year's Splendora ISD history fair is to be scheduled March 2026. The dates are not set. Our chapter will present a gift of \$2000 to the Splendora ISD for the history fair. Secretary Bill King reported that last month's meeting notes are included in the October Newsletter. Bill stated that the family SAR 250th bench was completed and was delivered to the Akron, Colorado cemetery shortly after Labor Day. A formal dedication is scheduled for Memorial Day 2026 in recognition of the 250<sup>th</sup> anniversary of the signing of the Declaration of Independence. Bill has been in contact with the Akron Veteran's Day ceremony coordinator who represents both the Akron American Legion and VFW. Bill has asked the SAR Colorado Long's Peak chapter if their color guard would be available for the ceremony. More details will follow.



Bill also encouraged our members to watch the YouTube SAR Revolutionary War Rarities series. A new video is posted every 2 weeks.

Treasurer B. Ray Mize reported that our chapter, through the efforts of Larry Stevens, purchased 20 JROTC medals and ordered Texas Challenge coins.

Registrars Kermit Breed and Larry Stevens reported that Pamela Anderson's grandsons SAR applications for Thomas and Christopher Anderson's applications for membership have been approved. Four additional applications are being worked on by Kermit and Larry. Kermit also formally asked our members to submit a short biography and photograph to him and he will submit these bios to the Texas SAR for inclusion in the Texas History Volume 3. He said there is a form on the website to help.

Larry Stevens attended the National SAR Trustee meeting in Louisville on October 3rd and said there were two items to report to the chapter, First, National SAR has contracted with an insurance company and that will provided insurance to cover all SAR Color Guard members participating in black powder events and other activities beginning November 1, 2025. State Society need to no longer contract for their own policies.

Second, Larry reported National SAR is in deficit so has not filled vacancies. Staff members who retired and were not replaced. National is actively trying to reduce the debt. There are currently only six staff Genealogist so it has taken longer to approve applications. Members are encouraged to keep their membership active by paying the yearly dues. Members are also encouraged to purchase life time membership.

The Texas 250<sup>th</sup> Monument recognizing Rev War Patriots buried in Texas will formally be dedicated in the Austin

State Cemetery

on April 17, 2026. Members should attend this historic event.

Skip Hayley was presented with the SAR University diploma for completing the course of VP duties. There are other courses you can take. The Youth Protection Training course is one available and is required by all members who work around youth.

David Hamaker reported that the Texas SAR is actively lobbying the State to include Spain's active involvement in the American Revolution. The Texas SAR has encouraged smaller Texas chapters to host Texas SAR conventions by reimbursement of cost endured to sponsor the convention.

Veteran's representative Ski Grumboski reported that our chapter had 371 wreaths donated to the wreaths over America last year. For our chapter's effort, we received a national chapter award. Additionally, a streamer was formally added to our chapter flag for our continued education activities for our local school districts.





Ski encouraged our members to purchase individual wreath through the "business card". Wreaths be purchased by November 28<sup>th</sup>. Ski also made a motion for our chapter to purchase 500 wreaths. During discussion \$1700 was proposed. Larry Stevens seconded the motion, and the motion was approved by all chapter members.

#### New Business:

Bill King made a motion for our chapter, and the Freedom Chapter jointly purchase a 250<sup>th</sup> anniversary bench in the Houston national cemetery. Ski Grumboski reported that he asked the cemetery committee for their approval.
